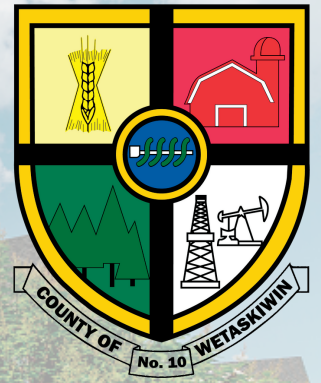


BUSINESS VISITATION PROGRAM
